Road Safety Audits (RSA):

A decade ago, only a few states had ever heard of a Road Safety Audit (RSA) and now every state has some experience with the RSA process. An RSA is a "formal safety performance evaluation of an existing or future road or intersection by an independent, multidisciplinary team." The Local Road Safety Plan (LRSP) offers a foundation for consensus and focus. It defines key emphasis areas and strategies that impact local rural roads and provides a framework to accomplish safety enhancements at the local level. The LRSP helps communities take a proactive stance in reducing and preventing local road fatalities and injuries.
