 Does not meet your needs, many versions, software and hardware upgrades, licensing, data crash, etc.


Custom Program (contracted or built in house)


*according to a recent study by PricewaterhouseCoopers

- 4 drawer cabinet: approx. 15,000 sheets, costs up to \$25,000 to fill and \$2,100 annually to maintain
- about 20% staff time is spent searching for documents
- Businesses spend an average of \$20 in labor to file every document, \$122 to find each misfiled document and \$220 to recreate every lost document(approx 7.5% of all documents are lost)
- Lack of Data Security and Confidentiality
- Lack of Disaster Recovery

Three Affiliated Tribes Hit by Ransomware Attack, Holding Tribal Information Hostage




HOW RANSOMWARE WORKS?




